- The Spruceview Select LMM US Buyout Access Fund I has received a positive reception from Latin American institutional investors and family offices, by offering co-investment opportunities in a highpotential segment such as US small and medium-sized companies.
- The milestone demonstrates the success of the alliance between Santander Alternative Investments and the U.S. asset manager Spruceview Capital Partners LLC in launching this Luxembourg-domiciled fund, which invests in private equity both directly and through specialist investment funds.

Santander Alternative Investments (SAI), the alternative investment manager within Grupo Santander's Asset Management business, and Spruceview Capital Partners today announce that their fund, Spruceview Select LMM US Buyout Access Fund I, has reached a first closing following strong interest from Latin American institutional investors and family offices.

The fund provides access to a market segment—small and medium-sized companies—with strong growth potential. Through this vehicle, SAI clients can benefit from an asset class that offers attractive opportunities amid the current dynamism of the U.S. economy. The strategy is carried out alongside a manager with proven experience and a solid track record in this type of niche transactions, which are characterized by high entry barriers. Specifically, the fund invests in companies with EBITDA below 50 million dollars at the time of investment.

Spruceview Capital Partners has offices in New York, Colorado, Mexico, and Chile. It has a specialized investment team that is deeply connected to the private equity Lower Middle Market segment focused on small and medium-sized enterprises, and it manages over 4 billion euros in assets, mainly on behalf of large institutions.

The vehicle, Spruceview Select LMM US Buyout Access Fund I, is domiciled in Luxembourg and aims to offer a diversified portfolio of investments in US medium and small companies, where entry multiples are potentially attractive and economic prospects are expected to be favourable. Additionally, it will combine direct co-investment opportunities in companies with stakes in private equity fund-of-funds within this segment.

In this way, the fund can invest in sectors such as healthcare, technology, manufacturing, and consumer goods, which are among those that, a priori, offer the greatest growth and profitability potential. The fund has been well received by both European and Latin American institutional investors—markets that Santander can access thanks to the combination of its global capabilities and strong local roots, with a presence in 10 key markets.
